A. TERMS OF USE ACCEPTANCE

B. MODIFICATION OF THE CONDITIONS OF USE

The Company reserves the right to modify, at its sole and unquestionable judgment, at any time and without notice, the conditions of use of the Site and its services. E. COOKIES
